PLEASE READ CAREFULLY

Dogs may not be shown unless entries have been received and listed in the show catalog (the only exceptions would be in the event omissions are due to printer's error).

A dog must be from properly nominated litter, owner must be a member of GSDCA to show in the Maturity. A dog may be entered in any ONE of the nine regions, but may NOT be entered in more than ONE region. In order to be eligible to be shown in the Maturity in 2007, a dog must have been entered in the 2006 Futurity.

Exhibitors may not enter their dogs under the owner or co-owners, or any member of the household of the immediate family of the owner or co-owner of the sire or dam of their entry, or under someone with whom the exhibitor co-owns any dog. Judges, Handlers and Exhibitors are requested to abide by the AKC guidelines regarding handlers not showing under a Judge for whom they have handled within a 4 month period.

#### PRIZES

Plaques will be awarded to the Best in Maturity and Best in Opposite Sex to Best in Maturity in each region. The winner of each class in the Maturity Section will have its picture in the German Shepherd Dog Review.

The German Shepherd Dog Club of America, Inc. will award a Silver Medal to the Best in Maturity and Best in Opposite Sex to Best in Maturity at the National Specialty Show in 2007.

Three R.O.M. points will be given to the sires and to the dams of the Best in Maturity and Best in Opposite Sex to Best in Maturity at the National Specialty Show in 2007.

If five or more animals are exhibited in this class at the National Specialty in 2007, the winners will be awarded the title of Maturity Victor and Victrix as determined by sex.

The Maturity Victor and Victrix each will be featured on a cover page of The German Shepherd Dog Review.

Entry in the class at the National Specialty Show for the winners of Best in Maturity and Best of Opposite Sex to Best in Maturity in each region and the reserves will be made by the National Futurity Chairman, and entrants agree by their signature on this entry to be governed by the rules and regulations applying to the National Specialty.

1. Dog may be entered in ONE region only and must be properly nominated.
  2. No fees will be refunded.
  3. Dog may NOT be entered under the owner or co-owner, or any member of the household, of its sire or dam.
  4. Exhibitors may NOT enter their dog under someone with whom they co-own any dog.
  5. Handlers should not exhibit under a judge for whom they have handled within a 4 month period.
  6. Non-GSDCA members may enter the Futurity. Only GSDCA members may enter the Maturity. Membership application may be made with entry.
  7. Check region carefully - region entered on entry form may NOT be changed after the close of entries.
  8. Futurity entries must supply Litter Nomination number.
  9. Maturity entries must indicate region entered in 2006 Futurity.
  10. If paying with a credit card, provide on a separate piece of paper: visa/mastercard number, expiration date, cardholders name and signature. \$4.00 per dog per show charged on all credit card entries regardless of method submitted. \$10.00 service charge will be applied to any invalid/declined credit card.
