***NOTICE TO EXHIBITORS* ENTRY FEE: \$30.00** (including \$.50 AKC recording Fee and \$3.00 AKC event service fee) for the first entry of a dog and **\$20.00** for each additional entry of the same dog. Puppy Classes (6-9 & 9-12 months) and Veterans Classes are **\$20.00** for first entry. Jr. Showmanship is free.

CLOSING DATE for entries 6:00 PM, Wednesday, **November 21, 2018** at the Show Secretary's Office, make fees payable in US funds to **GSDCEVA**. NO REFUND FOR DUPLICATE ENTRIES. We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances or other acts beyond the control of the GSDCEVA, it is impossible to open or to complete the show, no refund of entry fee will be made. NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE. ERRORS ON ENTRY FORMS. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

ACKNOWLEDGEMENT OF ENTRIES will be made as soon as practicable. Should acknowledgement not be received by the exhibitor within a reasonable time, please notify The Show Secretary, **Dania Karloff at (757) 482-3966 or (757) 642-3791 or dkarloff@aol.com**

ENTRIES NOT ON OFFICIAL AKC FORMS AND PHOTOCOPIES of entry forms without the Agreement and Rules on the reverse side are not acceptable. A recording fee of \$.50 and an event service fee of \$3.00 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in the show, the Recording fee and an event Service fee is to be collected on the first entry only. (AKC Rule, Chap. 11, Sect. 2) These Recording Fees and event service fees are to be collected by the Show-giving Club and paid to the American Kennel Club.

FEES MUST ACCOMPANY ENTRIES, Postdated checks and returned checks do not constitute a valid entry fee. The Show Secretary will add a collection fee of \$30.00 to the amount of each returned check. Subsequent returned checks from the same exhibitors will result in their being put on a CASH ONLY basis.

CANADIAN EXHIBITORS Make fees payable in US Funds. Consult Judging Program For the time of Judging, Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the Judging ring when their classes are called to be judged. Dogs not required for further judging will be excused.

ALL DOGS PRESENT MUST BE HELD ON LEASH OR CONFINED TO THEIR CRATES EXCEPT WHEN BEING JUDGED OR WHEN IN THE EXERCISE RING. EXHIBITORS AND HANDLERS WILL BE HELD RESPONSIBLE FOR CLEAN CONDITIONS IN AND AROUND THEIR CRATES. GSDCEVA WILL NOT BE RESPONSIBLE for the loss of, damage to, or death of any dog at the show or in transit to the show, or for the possessions of any exhibitor, whether the result of accident or any other cause. It is expressly understood that every dog at the show is in the care and custody and control of its owner or handler during the entire time the dog is on the show premises. NO ALCOHOLIC BEVERAGES PERMITTED ON SHOW GROUNDS EFFECTIVE MAY 1, 2004: Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable disease, and have appropriate vaccination. (Pursuant to Virginia Health requirements, proof of current rabies vaccination must be available if requested).

No dogs are to be left unattended in x-pens; no vehicles housing dogs will be allowed to be parked next to pedestrian thoroughfares at the motel; no dogs are to be left loose unattended in rooms.

Exhibitors please clean up behind your dogs. Un-entered dogs will not be allowed on the grounds during show hours. No puppies under 6 months of age are permitted on the grounds during show hours.

All persons attending this show hereby waive any claim for damages against the GSDC of E VA or GSDC of America, or its members, in the event of a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

We have an excellent relationship with the motel and the campgrounds and we want to keep it that way. Please be respective of their property so we can continue using their facilities. You will be held responsible for any damages, abuse, or additional clean up, etc.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly by any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person.

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3).
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
