## **SPECIAL COVID-19 TRIAL GUIDELINES**

We will be adhering to State of California, County of Sacramento and City of Carmichael public health regulations in addition to CDC and AKC guidelines. Our aim is to keep our judges, volunteers and exhibitors as safe as possible.

1. **If you feel unwell, have a fever, cough, sneezing, sore throat (or any other symptoms that have been associated with COVID-19), please stay home.**
2. **If within 14 days prior to the trials you have been in the presence of a person who has either tested positive for COVID-19 or has the symptoms noted above, please stay home.**
3. **PHYSICAL DISTANCING:** Maintain at least 6 feet between you and other exhibitors or spectators at all times. Avoid congregating to the extent possible. Avoid physical contact (shaking hands or hugging). Avoid touching dogs that are not your responsibility.
4. **FACE MASKS:** Per State of California health orders, face masks are required at all times while outside of one's home where physical distancing is not possible. Participants at this event must supply their own masks.
5. **PARKING:** Park with increased distance between vehicles whenever possible.

### **GENERAL PRACTICES**

Participants should wash hands as frequently as possible

Participants must provide their own method for cleaning up from their dogs in and around the show grounds

Prepare to be self-sufficient: bring sanitizer and personal use masks

Do not congregate at the ring or ring gate
