BRED-BY-EXHIBITOR CLASS

Effective September 18, 2002: 1) All dogs entered in the Bred-By Class must be individually registered with the AKC; 2) The individual handling the dog in the Bred-By Class must be a breeder of record and a current owner of record of the dog; 3) To exhibit in this class, family members must be a breeder and owner of record. In any subsequent classes for which a dog from the Bred-By Class becomes eligible, there are no restrictions as to who may handle the dog.

CLASS INFORMATION 4-6 MONTH BEGINNER PUPPY

The 4-6 Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.

AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.

A foreign-born dog may enter this class if they are registered in the country of origin.

All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol. Professional handlers are not permitted to exhibit in this class. Dogs that are owned or co-owned by a professional handler may compete in this class but must be handled by a non-professional handler. (Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.)

Class will not be divided by sex.

4-6 Month Puppy – Judging

- Individuals that have an AKC conformation judge's number are the required judges for the Four-to-Six Month Puppy competition. Judges assigned regular classes may not judge the Four-to-Six Month Puppy competition if it interferes or delays the judging of regular classes, Groups or Best in Show. The judging conflict requirements of 30 days and 200 mile between assignments will not apply to the Four-to-Six Month Puppy competition. A change in the listed judge due to an overload will not result in a return in the entry fee.
- Judges will be credited with an enriching component for breeds judged in the 4-to-6 Month Puppy competition. Judges of this competition may also exhibit on the day(s) they judge.
- Exhibitors should open their dog's mouth for examination. If the judge finds it necessary to open the mouth they should disinfect their hands prior to examining other dogs. Judges will comply with the Rules, Policies and Guidelines for Conformation Judges except the speed of judging may be reduced to 20 dogs an hour.
- Professional handlers, members of their household and current assistants to professional handlers may not personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition. Dogs that are owned or co-owned by the forenamed may compete in this competition but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.* **Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.**
- Male puppies without 2 fully descended testicles need not be disqualified or excused but the judge's book must describe the condition and Certificate of Merit points must be withheld.
- Dogs with breed standard disqualifications should not be excused but may not receive placements. However, dogs with age related disqualifications such as color (as related to age), height, teeth etc. are permitted to receive awards in the 4-to-6 Month Puppy classes.
- Dogs must be excused for attacking a person or other dogs.
- No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears or tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed.

ATTENTION EXHIBITORS

Water is available at the show site, there is no electricity available.

No lunch will be available.

LOUIS, ILLINI GERMAN SHEPHERD DOG CLUB, THE GERMAN SHEPHERD DOG CLUB OF AMERICA, nor anyone connected with the presentation of this event, assumes any responsibility for any loss, damage or injury sustained by spectators, exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to their families or children.

The American Kennel Club Rules and Regulations will govern these Events. Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry form that accompanies this Show Premium List.

Dogs need to be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the clubs nor show secretaries will be responsible or obligated to furnish any service for notifying exhibitors or their agents of class being judged. All dogs present must be held on leash or confined to their crates.

Judges need not wait for any dog holding up the judging of a class. Owners or their agents alone are responsible for the presence of their dog(s) in the judging ring.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or a judge; or barred from competition due to their violation of any rules or regulations set forth by the show-giving clubs.

NO FAX ENTRIES. Any overnight private carriers requiring a signature upon delivery will not be guaranteed to be received in time to meet required deadline for closing.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures. **Entries must be on Official AKC Entry Forms.** Changes, additions, or corrections to entry forms must be received in writing or by electronic mail prior to the close of entries. Entries received by telephone are not acceptable.

No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, an Act of God, public emergency, act of public enemy, strikes, or any other cause beyond the control of the show-giving club or show secretary.

Returned checks do not constitute a valid entry fee. There will be \$40 fee on returned checks. Subsequent returned checks from the same exhibitors may result in their being put on a cash only basis. Canadian exhibitors: make checks/money orders in U.S. funds.

Entries will be acknowledged after entries close with entry acknowledgment and judging program sent via email. Should Exhibitor NOT receive an acknowledgment within a reasonable time contact the Show Secretary. **Refunds for cancellations due to judge change or cancellations made prior to entries closing will be mailed to said Exhibitor or Agent AFTER THE SHOW. An administrative fee of \$5.00 will be withheld from all refunds for entries cancelled prior to closing.**

An Event Service Fee of \$3.00 and a Recording Fee of \$.50 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial, or Tracking Test (4-6 Puppy \$2.00 Event Serve Fee). These fees are to be collected by the show-giving club and paid to The American Kennel Club. If a dog is entered in more than one class, the Recording Fee is to be collected on the first entry only (AKC Rule, Chapter 15, Section 2).

If veterinary attention is required, the exhibitor is responsible for the veterinarian's emergency fee and medical expenses incurred.

LOSS OR DAMAGE – The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in these Shows. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor. It is distinctly understood that Exhibitors will exercise control and restraint over their children.

ALL videotaping or photography during the show requires permission from the show-giving club.

ONLY THE OFFICIAL SHOW PHOTOGRAPHER MAY TAKE WIN PHOTOS WHICH INCLUDE THE JUDGE.

ALL prizes must be claimed the day of the show—none will be mailed.

BELOW ARE RULES THAT MUST BE FOLLOWED:

1. ALL DOGS TO BE EXERCISED IN DESIGNATED AREAS ONLY, both at the show site and at area hotels (if so designated).
2. Dogs must be kept on leash at all times while on show or hotel grounds.
3. Limit of 2 dogs per hotel room (unless otherwise specified)
4. Unattended dogs must be crated in hotel rooms.
5. Absolutely no bathing or grooming of dogs is allowed in hotel rooms.
6. Dog owners/agents are responsible for timely clean up and disposal of any waste – both at show grounds and at their respective hotels.
7. Dog owners and/or their agents are personally responsible to area hotels for any damage caused thru their negligence.
8. **All pop-up tents, etc., as well as chairs must be set back from the ring a minimum of 4 feet.**

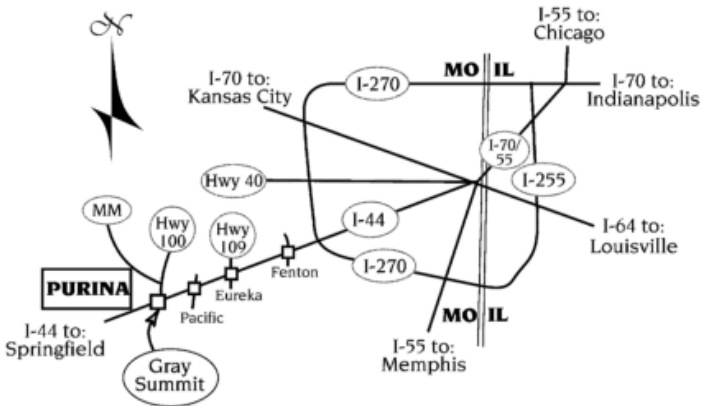

Purina Farms Overnight Camping Reservation Request Form

Thank you for requesting an overnight camping space in one of the Purina Farms designated RV lots. Reservations are taken on a first-come; first-served basis and are assigned based on length of equipment (rig) and space availability. If confirmed, you will receive an emailed confirmation and a payment link so you can pay at your convenience. Our RV Engagement Specialist will respond back to your reservation request within 5-7 business days to let you know whether your reservation is confirmed. Full payment must be received before the space can be confirmed and finalized.

Purina Farms offers 2 different RV lots on property. The Full Service Purina Event Center RV lot offers 30 and 50 amp electric, water and sewer. The Electric Only Main Show Field RV lot offers 30 and 50 amp electric.

Any RVs bigger than 50' must reserve a spot in the full-service Purina Event Center lot. Max size of RV on property is 55'. Tow vehicles are not factored into the length of the spaces as they must be unhooked.

Spaces are refundable if cancelled more than 3 days out from the arrival date listed on the reservation confirmation. Otherwise, no refunds will be given. Spaces are non-transferable.

Please note that RV reservations are only accepted for those entered (or those who have dogs/cats entered) in an event that has contracted space, which includes the overnight camping lots.

The Purina Farms RV lots are only open to vehicles specifically designed with overnight sleeping accommodations including motorhomes, fifth wheels and travel trailers.

Quiet time in the RV area is from 11:00PM to 6:00AM.

If you have an RV rental, you must ensure that the RV is dropped off and picked up in accordance with your reservation dates and times. Plan accordingly with the supplier.
