The Show Giving Club assumes NO responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or any of their dogs or property and assumes no responsibility for their children.

All Cash Prizes, Ribbons, and Trophies will be given in the ring to the person showing the dog. Claims for ribbons, trophies, or prize money must be made in the ring before the judging of the class is over.

The German Shepherd Dog Training Club of Chicago, Inc. disclaims any liability for cash prizes, ribbons, and trophies after the judging of the class is over. Absolutely No Trophies, Ribbons, or Prizes will be mailed.

No dogs will be allowed on the show grounds that are not entered in this trial. All dogs entered must remain on leash, except as required in the ring for competition or confined to their crates.

Females in Season are not permitted to compete. If a female is withdrawn from competition because it came into season, the Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. The club will refund the entry fee, minus a \$10.00 processing fee. The Club will require documentation from the Veterinarian confirming the female to be in season before a refund can be given.

#### MAP DIRECTIONS

**FROM THE NORTH:** Take the Elgin-O'Hare Expressway to the Lake Street Exit and turn West. Take Lake Street to the first traffic light, Ontarioville Road, and turn South (left). Take Ontarioville 0.5 miles to County Farm Road and turn South. Continue south about 2 miles.


**FROM THE SOUTH:** Take Route 53, I-355 Tollway, or Route 59 to Army Trail Road. Take Army Trail Road to County Farm Road and turn North. Schick Road is the first traffic light - continue north about 0.5 mile.

**FROM LAKE STREET:** Take County Farm Road South to the Club, or take Gary Avenue off Bloomingdale Road South to Schick Road. Turn right (West) on Schick Road to County Farm. Turn right (North) on County Farm Road. Continue north about 0.5 mile.

**FROM THE WEST:** Take North Avenue (Route 64) to County Farm Road, turn left (North) on County Farm Road. Schick Road is the first traffic light - continue north about 0.5 mile.

**FROM THE EAST:** Take North Avenue (Route 64) to County Farm Road, turn right (North) on County Farm Road. Schick Road is the first traffic light - continue north about 0.5 mile.
