ENTRY FEE: EACH SHOW: See the individual premium lists for entry fees. CLOSING DATE for all entries is 6:00 PM Wednesday, June 21, 2023, at the Show Secretary's address, after which time entries cannot be accepted, canceled or submitted. THE SHOW will be open from 8:00 AM to 8:00 PM.

A RECORDING FEE OF \$.50 AND A SERVICE FEE OF \$3.00 will be required for each dog entered at any Licensed or Member Club show, Obedience Trial or Tracking Test. These fees are to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, the Recording Fees are to be collected on the first entry only. An AKC Recording Fee of \$3.00 will be required for each entry in any Licensed or Member Club Rally Trial. If a dog is entered in more than one class in a Rally event, the AKC Recording Fee is to be collected on each of the entries of that dog.

**RETURNED CHECKS** do not constitute a valid entry fee. The Treasurer will add a \$30.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a **CASH ONLY basis**.

TELEPHONE, TELEGRAPH, AND UNSIGNED ENTRIES CANNOT BE ACCEPTED. ENTRIES NOT ON AN OFFICIAL AKC ENTRY FORM AND PHOTOCOPIES OF ENTRY FORMS without the agreement and rules on the reverse side of the Official AKC entry form are not acceptable.

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels ( King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
