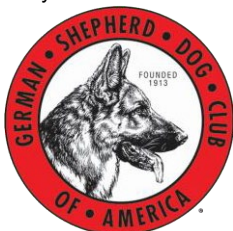

## Move Up Policy

**Prior to trial:** Move-up Deadline is Monday at Noon October 16, 2023, and will be taken via email to [gsdscaswnational2023@gmail.com](mailto:gsdscaswnational2023@gmail.com) NO EXCEPTIONS!!!

**During trial:** We will be taking day to day move ups, there will be no move ups from Trial 1 to Trial 2 for each day. All move ups must be completed in writing by end of trial Saturday and Sunday, no move ups will be taken Sunday or Monday morning or by email, phone call, text or fax.

Move ups prior to trial day must be submitted by 8am Monday Sept 4, 2023, no move ups will be taken after this date no exceptions.

The exhibitor is fully responsible for entering the dog in the correct class or classes.

## DOGS ELIGIBLE TO ENTER

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners (mixed breed) listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners (mixed breed) listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter.

Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

Waiting List.** Clubs that limit the number of entries may, at their option, establish a waiting list in order that entries that scratch prior to the event can be replaced. The waiting list shall utilize a "first in – first out" approach. **A full refund is to be reimbursed to any entrant whose entry is replaced by a wait-listed entry.** This waitlist will close on **Monday October 16 at 8am** after which time no refunds will be given or entries replaced.

## NOTICE TO EXHIBITORS

### **SAFETY, BEHAVIOR and LIABILITY**

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all exercises safely.

**It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The German Shepherd Dog Club of America and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The German Shepherd Dog Club of America reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the German Shepherd Dog Club of America or any official thereof.

**All dogs must be on leash** at all times when on trial grounds except when competing in the event

### **REFUNDS**

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

**Females in season** are not permitted to compete in scent work. If a female is withdrawn from competition because it came into season, the club will refund entry fees for bitches unable to compete. The Trial Secretary must be notified no later than one half hour prior to the start of the first class of the day of the trial. The club will retain a processing fee of \$5.00 per trial.

### **REWARDS AND REINFORCERS**

When a dog correctly finds the scent, the handler may reward the dog with food or toy reinforcement. Handlers may reward at or away from source but must take care not to contaminate the search area with food particles or saliva. If a toy is used, the toy must always stay in contact with the handler (toys cannot be thrown). Toys that make noise are not allowed. These items are to be used as a reward only and may not be used to bait the dog.

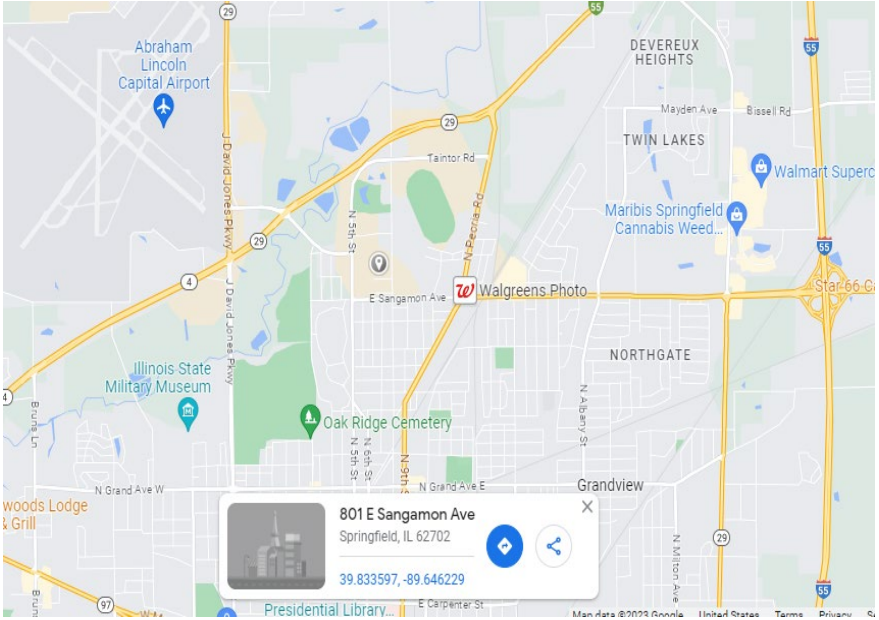

By signing the entry forms for these dog shows you are agreeing that clean-up is your responsibility. If you see an area that has not been cleaned, please notify our announcer at the catalog table. Not cleaning up after your dog may result in dismissal from trial and forfeiture of entry. It is **not appropriate to visit the trial location** prior to the trial date.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
