The following information is due when you send in your dues to renew your GSDCA Regional Club Membership. If you will READ AND FOLLOW THE INSTRUCTIONS, THIS CAN BE HANDLED SMOOTHLY. PLEASE CALL WITH ANY QUESTIONS.

The approval process is for you to submit the requested information to me. Once it is all in, I tell Gail that you are approved for shows and she then submits to AKC.

Your Regional Club dues are payable by **December 31st** unless you need approval for shows for early the following year, then they should be paid **22 weeks** before final approval is needed. (Example: Show date first week in January - dues should be paid and updated information provided by August 1st, show date second week in January - dues & updated information due by August 8th, etc.)

If the club does not comply, they are likely not to receive approval to hold their shows.

- 12-30 Members - \$65
- 31 or more Members - \$85
