Qualifying Scores are required for all Obedience Prizes offered. Please note: No ribbons or awards will be mailed.

ATTENTION EXHIBITORS

A recording fee of \$3.50 will be required for each dog entered at any Licensed or Member Show, Obedience Trial, or Tracking Test. This recording fee is to be collected by the show-giving club and paid to the American Kennel Club. If a dog is entered in more than one class in the show, an additional recording fee of \$3.50 is to be collected (American Kennel Club Rule, Chapter 11, Section 2 amended).

The Show Giving Club assumes NO responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or any of their dogs or property and assumes no responsibility for their children.

All Cash Prizes, Ribbons, and Trophies will be given in the ring to the person showing the dog. Claims for ribbons, trophies, or prize money must be made in the ring before the judging of the class is over.

The German Shepherd Dog Training Club of Chicago, Inc. disclaims any liability for cash prizes, ribbons, and trophies after the judging of the class is over. Absolutely No Trophies, Ribbons, or Prizes will be mailed.

No dogs will be allowed on the show grounds that are not entered in this trial. All dogs entered must remain on leash, except as required in the ring for competition or confined to their crates.

Females in Season are not permitted to compete. If a female is withdrawn from competition because it came into season, the Trial Secretary must be notified no later than one half hour prior to the start of the first class in the trial. The club will refund the entry fee, minus a \$10.00 processing fee. The Club will require documentation from the Veterinarian confirming the female to be in season before a refund can be given.

The German Shepherd Dog Training Club of Chicago, Inc. believes in responsible dog ownership. For your convenience, an exercise area is provided on the northeast corner of our property. You are expected to clean up after your dog. Scoopers are available at various locations on the grounds for your use.

MAP DIRECTIONS

FROM THE NORTH: Take the Elgin-O'Hare Expressway to the Lake Street Exit and turn West. Take Lake Street to the first traffic light, Ontarioville Road, and turn South (left). Take Ontarioville 0.5 miles to County Farm Road and turn South. Continue south about 2 miles.


FROM THE SOUTH: Take Route 53, I-355 Tollway, or Route 59 to Army Trail Road. Take Army Trail Road to County Farm Road and turn North. Schick Road is the first traffic light - continue north about 0.5 mile.

FROM LAKE STREET: Take County Farm Road South to the Club, or take Gary Avenue off Bloomingdale Road South to Schick Road. Turn right (West) on Schick Road to County Farm. Turn right (North) on County Farm Road. Continue north about 0.5 mile.

FROM THE WEST: Take North Avenue (Route 64) to County Farm Road, turn left (North) on County Farm Road. Schick Road is the first traffic light - continue north about 0.5 mile.

FROM THE EAST: Take North Avenue (Route 64) to County Farm Road, turn right (North) on County Farm Road. Schick Road is the first traffic light - continue north about 0.5 mile.

GSDTC Club House (large red building) is on the East side of the road.

I, (we), acknowledge that the "Rules Applying to Dog Shows" and, if this entry is for an obedience trial, the "Obedience Regulations", have been made available to me (us), and that I am (we are)familiar with their contents. I (we) waive any and all claims, causes of action, I (we) might otherwise have against the AKC and any AKC approved judge, judging at this show, under AKC Rules, Regulations and Guidelines. I (we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies. I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage, or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause of causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this show or obedience trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.

INSTRUCTIONS

- 1 (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, particolor); Beagles (not exceeding 13"in., over 13" in., but not exceeding 15" in.); Dachshunds (longhaired, smooth, wirehaired); Collies (rough, smooth); Bull Terriers (colored, white); Fox Terrier (smooth, wire); Manchester Terriers (standard, toy); Chihuahuas (smooth coat, long coat); English Toy Spaniels (King Charles and Ruby, Bienheim and Prince Charles); Poodles (toy, miniature, standard).
- 2 The following categories of dogs may be entered and shown in Best of Breed competition; Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3 (Dog Show Class) Consult the classification in this premium list if the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4 A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rule refer to Chapter11, Section 3.)
