AN AKC RECORDING FEE OF 50¢ & AKC Event Service Fee of \$3.00 for the first entry of a dog & a \$3.50 service fee each additional entry of the same dog in an event will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. If a dog is entered in more than one class in one of these events, the recording Fee is to be collected on the first entry only. (AKC Rules Applying to Dog Shows, Chapter 11, Section 2).
