TRANSFERS will be allowed at this trial. Dogs which according to their owners' records have earned an obedience or rally title after the closing of entries for the show may be moved up to the next class, provided this transfer is made in writing and presented to the Secretary by the close of the trial.

PRE-SHOW SETUP: No set-ups allowed the night before the trial.

Eligibility This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds. Bitches in season, aggressive, blind dogs or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are ineligible to participate.

Refunds

- Full entry fees will be refunded if an entry is pulled before the closing date/time.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.
- Host club is under no obligation to offer refunds for duplicate entries for the same dog.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbance, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- No refunds for overpayment of entry fees will be made for \$10.00 or less.
- Refunds for bitches that come into season after the close of entries: all entry fees less \$7 will be refunded if the Trial Secretary receives WRITTEN notice of withdrawal no later than one half hour prior to the start of the first class of the day of the trial. Bitches in season will not be allowed on AKC showgrounds.
- Refunds for dogs injured after the close entries: all entry fees less \$7 will be refunded if the Trial Secretary receives WRITTEN notice of withdrawal no later than 24-hours before the start of the trial. A letter from your veterinarian will be required.
- No refunds for withdrawals due to injured or sick handlers.

General Procedures

- The Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Kennel Club or any official thereof.
- Do not leave any dogs in closed vehicles.
- There shall be no drilling nor intensive or corrective training of dogs on the show grounds or premises.
- All dogs shall be kept on leash except when in the Obedience or Rally rings, or exercising ring or confined in crates.
- Any change or cancellation must be made in writing and received prior to closing, except as provided in Chapter 11, Section 6 of the American Kennel Club Dog Show Rules and Regulations. Telephone Entries and Unsigned Entries Cannot Be Accepted. Entries Not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE.
- Entries received without fees will not be accepted. Email acknowledgement of entries will be made as soon as practical after receipt by the Trial Secretary. Should acknowledgement not be received by the exhibitor within a reasonable time, please notify the event secretary
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, communicable diseases, and have appropriate vaccinations.
