**Attention Owners / Exhibitors of Foreign Registered Dogs**

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC), please review the eligibility requirements in The Rules Applying to Dog Shows, Chapter 11 Section 1. The dog show rules are posted on the AKC Web site at: <http://images.akc.org/pdf/rulebooks/RREGS3.pdf>. Most important to note are the following:

1. Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period, the dog must be either individually AKC registered or by the date of the event, have been granted an extension to exhibit using the foreign registration. The owner or agent can request an extension using the form found on the AKC Web site at: <http://images.akc.org/pdf/extenap.pdf>.

## TRIAL REGULATIONS

**ENTRIES CLOSE AT THE SHOW SECRETARY'S OFFICE**, by 6:00pm, Wednesday, April 17, 2024, after which time entries cannot be accepted, altered, canceled, or substituted. Make check payable to MAC Dog Shows LLC. Canadian exhibitors must have fees payable in US Funds.

**RETURNED CHECKS** do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of **\$40 to each returned check**.

**ENTRY FORM MUST BE SIGNED** by the owner or the owner's duly authorized agent, otherwise the entry cannot be accepted. Telegraph or telephone entries cannot be accepted.

**OVERNIGHT deliveries** requiring **NO** signature only. Entries not on official AKC entry forms or photocopies of entry forms without the Agreement & Rules on the reverse side of the official AKC Entry Form are NOT ACCEPTABLE.

**An AKC Recording Fee of \$0.50 first entry only and an AKC Event Service Fee of \$3.00 for first entry and \$3.50 for each additional entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each first entry and \$3.50 for each additional entry in any Licensed or Member Club Rally Trial. An AKC Event Service Fee of \$2.00 per entry will be required for each dog entered at any Open Show.** All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions) these Fees are to be collected by the show giving Club & paid to the AKC. (AKC Rule, Chapter 11, Section 2).

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competing by action of the Trial Committee.

**DOGS MAY ARRIVE** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused. All dogs present must be held on leash in hand except when being judged.

**NO ENTRY FEES WILL BE RETURNED** if the show cannot open or be completed by reason of riots, civil disturbances, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the management.

**OWNERS ARE RESPONSIBLE** for errors in making out entry forms, whoever may make such errors, & no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date. PLEASE TYPE OR PRINT carefully, the information on entry forms to eliminate errors.

**NO ENTRY SHALL BE MADE** & no entry shall be accepted which specifies any conditions as to its acceptance.

**DECLINATION OF ENTRIES**, the **German Shepherd Club of Northern Ohio, Inc.**, may decline any entries & may remove any dog on account of disease, viciousness, or other cause & no one shall have any claims against The German Shepherd Club of Northern Ohio, Inc., or any official thereof.

**DOGS MUST BE READY FOR JUDGING.** Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The show giving club has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**DOGS NOT REQUIRED FOR FURTHER JUDGING** will be excused.

**ALL AWARDS MUST BE CLAIMED** at the Show, or they become the property of The German Shepherd Club of Northern Ohio, Inc. None will be mailed.

**ALL DOGS PRESENT MUST BE HELD ON LEASH** or confined to their crates except when being judged or when in the exercise ring.

**CLEAN UP:** All exhibitors, owners, and/or handlers are asked to clean up after their own dog.

**CASH PRIZES** will be paid in the ring to the person showing the dog.

**CLAIMS FOR PRIZE MONEY** must be made in the ring before the judging of that class is over and Show Secretary advised at once. The show secretary and show-giving club may disclaim any liability for cash prizes after the judging of the class is over. **NO PRIZES WILL BE MAILED.**

**From the North:** Take I-77 S toward Akron / I-77 South, at Exit 156, head right on the ramp for I-480 toward Toledo / Youngstown; Keep left, heading toward Youngstown; at Exit 26, head left on the ramp for US-422 / I-271 North toward Erie / Pa / Warren; take the ramp on the left for I-271 North / US-422 West and head toward Chagrin Blvd / Harvard Rd; at Exit 29, head on the ramp right and follow signs for OH-87 / US-422 West; turn right onto OH-87 / Chagrin Blvd toward Orange / Pepper Pike / Woodmere; at the roundabout, take the 4th exit; keep right to stay on OH-87 / S Woodland Rd; arrive at OH-87 / S Woodland Rd.
