RULES APPLYING TO ALL CLASSES:

- Dogs may not be shown unless entries have been received & listed in the show catalog (the only exceptions would be in the event omissions are due to printer's error).
- To be eligible to exhibit in a Futurity, **puppies MUST be at least 6 months of age**, from a properly Nominated litter. (Documentation of litter nomination number is required on entry.) **Eligible puppies may be entered and shown in each Regional Futurity provided the puppy has not been awarded Best Dog, Best Bitch, or Reserve in a 2024 Futurity.**
- To be eligible to exhibit in the Maturity in 2024, a dog or its litter must have been properly nominated and entered but not necessarily shown in one of 2023 Futurity shows. Documentation of the 2023 Futurity region entered in is required on the entry. Owners of dogs from a nominated litter that were not entered in a 2023 Futurity may pay a \$150 fee to show in a Maturity. This fee is in addition to the participation/entry fee to enter the show.
- **Eligible dogs or bitches may be entered and shown in each Maturity, provided the dog/bitch has not been awarded Best Dog, Best Bitch, or Reserve in a 2024 Maturity.**
- **Dogs owned by non-GSDCA members may compete in REGIONAL Futurity/Maturity shows only. Dogs/bitches eligible for the National Finals MUST have at least one owner who is a GSDCA member. See National Specialty Finals info page 9.**
- AKC Champions of Record may compete, and professional handlers may participate.
- Exhibitors may NOT enter their dogs under a judge who is the owner or co-owner, or any member of the household of the immediate family of the owner or co-owner of the dam of their entry.
- Exhibitors may NOT enter their dogs under a judge who is a breeder of their entry.
- Change of judge: Due to a change of the named judge after closing, should an exhibitor wish to pull their entry, he/she can enter next year's Maturity, and is not required to enter a different Futurity this year.
- Exhibitors may NOT enter their dogs under any judge with whom they co-own any dog.
- Judges, handlers, and exhibitors are REQUIRED to abide by the AKC guidelines regarding handlers not showing under a judge for whom they have handled during the prior 6 months.
- No cryptorchid dogs (unilateral or bilateral), spayed or neutered dogs, or any dog with a Disqualifying Fault under the GSD Breed Standard may compete in any Futurity. AKC Rules Applying to Dog Shows: Chapter 11, Section 8. "When the judge of a sweepstakes or futurity finds that a dog is ineligible to compete under this section, the dog should be excused. A dog may only be disqualified in a sweepstakes or futurity under the provisions of Chapter 11, Section 8-A."

WINNERS CLASSES – DIVIDED BY SEX

Best Futurity Dog and Best Futurity Bitch will be selected from the first-place winners in Junior, Teenage, Intermediate, and Senior classes. A Reserve Futurity Dog and Reserve Futurity Bitch will be selected. Best in Futurity and Best of Opposite Sex in Futurity will be selected from Best Futurity Dog and Best Futurity Bitch.

Best Maturity Dog and Best Maturity Bitch will be selected from the first-place winners in Junior and Senior classes. A Reserve Maturity Dog and Reserve Maturity Bitch will be selected. Best in Maturity and Best of Opposite Sex in Maturity will be selected from Best Maturity Dog and Best Maturity Bitch.

RIBBONS, ROSETTES AND PLAQUES

- First place through Fourth place – Ribbon & Plaque
- Reserve Futurity Dog & Bitch and Reserve Maturity Dog & Bitch - Rosette
- Best in Futurity & Best Opposite Sex to Best in Futurity and Best in Maturity & Best Opposite Sex to Best in Maturity – Rosette & Plaque

REGIONAL PRIZE MONEY

The club will retain 50% of entry fees for expenses. [1] see page 7 The remaining 50% of entry fees for each region will be returned as prizes. Distribution of prize money depends upon the number of entries in each Futurity & Maturity. The allocation is as follows:

- 60% of the Futurity entries for Best in Futurity
- 40% of the Futurity entries for the Best of Opposite Sex in Futurity
- 60% of the Maturity entries for Best in Maturity
- 40% of the Maturity entries for the Best of Opposite Sex in Maturity

Prize money checks are made out to the first owner on the entry form and mailed to the address listed on the entry form. The responsibility of division of the prize money is up to the co-owners in accordance with their coownership agreement. The responsibility of providing the correct address on the entry form is that of the person making the entry. **Prize money checks must be cashed within 90 days and will not be reissued. Uncashed checks will be considered a donation to the Futurity System.**

GSDCA MEMBER BREEDER TROPHY

In any region where at least twenty-five (25) dogs/bitches are shown in the Futurity classes, (excluding dogs excused or disqualified) the Breeder of the Best in Futurity at that regional show will receive a GSD statue on a wood base. If there are additional persons listed as Breeders on the AKC Registration Certificate, they may purchase a bronze GSD Statue on a wood base from the GSDCA for cost plus shipping. Breeders must be a GSDCA member to receive this award.

GSDCA NATIONAL SPECIALTY FINALS COMPETITION

Best, Best of Opposite Sex and the Reserve winners from each region shall be eligible to compete at the GSDCA National Specialty Show for the title of GSDCA Futurity Victor & Victrix and Maturity Victor & Victrix as determined by sex. **THESE DOGS MUST BE OWNED OR CO-OWNED BY A GSDCA MEMBER. NON-MEMBER OWNERS MUST APPLY AND PAY FOR GSDCA MEMBERSHIP PRIOR TO SEPTEMBER 15, 2024, IN ORDER FOR THEIR DOGS TO BE ELIGIBLE TO COMPETE IN THE NATIONAL SPECIALTY FINALS COMPETITION.** Dogs and bitches eligible for the National finals and owned or co-owned by a GSDCA member are automatically entered. No additional entry is required.

The German Shepherd Dog Club of America, Inc. will award a Silver Medal to the Best in Futurity and Maturity and the Best Opposite Sex to Best in Futurity and Maturity at the National Specialty Show.

Three ROM points will be given to the sires & dams of the Best in Futurity, Best of Opposite Sex in Futurity, Best in Maturity & Best Opposite Sex to Best in Maturity at the National Specialty Show.

Futurity and Maturity Victor & Victrix will be featured on a cover page of The German Shepherd Dog Review.
