A – Begleithundprüfung auf dem Übungsplatz oder freiem Gelände

			Punkte	Note
1	Leinenführigkeit On-Leash Heeling	30	50 paces, about turn, 10-15 steps normal, then running pace then slow pace then normal pace then halt. Heel straightway into the group, then go back to the starting point.	
2	Sitzübung Sit Exercise	10	Heel in a straight line 10-15 steps, then halt (OR not halt) and give a verbal command to sit. Handler then walks ahead another 15 steps, stops, turns to the Dog, and returns to the Dog on Judge command.	
3	Ablegen in Verbindung mit Herankommen Down with Recall	10	Heel in a straight line 10-15 steps, Handler halts (OR not halt) and give a verbal command to down. Handler then walks ahead about 30 steps, turns, and recalls Dog on Judge command. Dog should return and assume a front position, then to Heel position.	
4	Ablegen des Hundes unter Ablenkung Down under Distraction	10	Dog is leashed and heeled to the Down location then unleashed. Judge instructs Dog to be downed. Handler moves away 10m, stops, stands sideways to Dog. Judge instructs Handler to return.

B – Prüfung im Verkehr

1	Begegnung mit Personengruppe	Handler/Dog walk and are cut off by a passer-by. Dog remains neutral until person leaves. Handler/Dog go through a group of 6 people, one person speaks to Handler, shakes hand and converses. Dog must sit or down on command and remain calm.
2	Begegnung mit Radfahrern	Handler/Dog walk and a cyclist passes from behind (bell). Cyclist turns and comes to to Handler/Dog (bell) and stops beside them. Dog is between the Handler and cyclist. Dog must behave in an unbiased manner.
3	Begegnung mit Autos	Handler/Dog walk past several cars. One car starts engine as Dog approaches. Another car slams door on approach. Another car stops next to Handler/Dog, rolls down window for information. Dog sits or downs on command. Dog remains calm.
4	Begegnung mit Joggern und Inline Skatern	Handler/Dog walk along and 2 joggers/skaters overtake him. Once past, the persons return and pass back again. Dog may sit or down but not disturb them
5	Begegnung mit anderen Hunden	Handler/Dog walk along and go past an approaching Handler/Dog. Dog must remain neutral. Handler may command to Heel or "Sit" or "Down" during the encounter.
6	Verhalten des kurzfristig im Verkehr angeleint allein gelassenen Hundes, Verhalten gegenüber Tieren	Handler/Dog walk along until Judge instructs to leash the Dog to a fence/wall. Handler goes out of sight. Dog may stand/sit/down. During absence, a person with a leashed Dog moves past at a safe distance. Dog #1 remain calm. Dog #2 also no reaction
