Regulations

Section 1- Classifications

The Four-to-Six Month Puppy competition shall be for dogs that are four months of age and over but under six months on the day of the event.

Section 2 – Entry and Eligibility

Entry and eligibility requirements include:

- The Four-to-Six Month Puppy event may be offered at licensed or member dog shows at the option of the show giving club.
- Four-to-Six Month Puppy Competition must be listed in the premium list, entry form and judging schedule, if offered.
- Closing date and time for this competition may be listed as any date and time prior to the event including the same day as the event and must be listed in the premium list, entry form and judging schedule.
- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.
- A foreign born dog may enter this class if they are registered in the country of origin.
- FSS number or FSS registered litter number will be required for Miscellaneous and FSS breed entries.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.

NOTICE TO EXHIBITORS

ENTRY FORM INFORMATION

1. Closing dates for the entries is 8:00 p.m., Wednesday, March. 4, 2026, at the SHOW SECRETARY'S address, after which time entries cannot be accepted, canceled or substituted.
2. Conditional, unsigned, incomplete, telegraphed or telephoned entries cannot be accepted.
3. Owners are responsible for errors on entry forms.
4. Entry fees will not be refunded in the event of error, cancellation of the entries after the published closing date nor in the event that a dog is absent, disqualified, excused by the Veterinarian or Judge or barred from competition by action of the Show Committee or because the dog is ineligible to compete due to incorrect entry.
5. Changes or additional information cannot be made by telephone. Such information must be received in writing by email or telegraphed prior to closing of entries as published in the premium list.
6. Entry fee will not be refunded if the show cannot open or be completed by reason of riots, civil disturbance, fire, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club or Show Chairman.
7. Returned checks do not constitute a valid entry fee. The Club Treasurer will add a collection fee of \$20.00 to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a cash only basis.
8. Refunds for cancellations prior to the closing will be made after the show.

15. A recording fee of 50¢ and an event service fee of \$4.00 will be required for each dog entered at any licensed or member club show, obedience trial or tracking test. This recording fee is to be collected (as part of Entry fee) by the show giving club and paid to the AKC. If a dog is entered in more than one class in the show, the recording fee is to be collected on the first entry only. (American Kennel Club Rule, Chapter 14, Section 20).

JUDGING

1. These shows will be open from 7:00 a.m. to 7:00 p.m. daily.
2. There is no provision for un-entered dogs at this show.
3. Dogs must be ready for judging. No provisions are available for notifying exhibitors or their agents of breed or class judging. Judge need not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring.
4. Dogs need be at the show only at scheduled judging time and may leave immediately thereafter unless required for further judging.
5. This show is un-benched.

RULES AND REGULATIONS

1. Set-up in designated areas only.
2. All dogs must be held on leash or kept in crates or pens except when being judged.
3. The San Bernardino-Riverside German Shepherd Club, German Shepherd Dog Club of the San Gabriel Valley and/or Show Secretary will not be held liable for any loss, damages or injury sustained by exhibitors, handlers or any of their dogs or property and further assumes no responsibility for injury to children.
4. This show will be governed by the rules and regulations of the AKC. Exhibitors are advised to make themselves familiar with the agreement of the AKC referred to on the reverse side of the entry form that accompanies this Premium List.
5. **THIS IS A SELF-CLEANING SHOW.** A Bench Show Committee will be called on anyone not cleaning up after their dog or their grooming space and a minimum of \$250.00 fine will be assessed.

Directions to the Trial Site / Parking Instructions / Special Set Up Instructions

From the North or South:

Exit Lewis Road from US-101 North or South, proceed south on Lewis Rd (past Pleasant Valley Rd) until you get to University Drive. There is a stop light at this intersection and it is on top of a rise in the freeway (similar to an overpass). Turn left. Initially this is a two lane entry to the University but will narrow to a single lane immediately upon entering. It dead ends at a stop sign at Santa Barbara Ave. Turn right and then left onto Ventura Rd (no other options). Then turn right immediately into lot A4. This is the closest lot for OB / Rally. Please be sure to display your parking permit. You must get a parking permit daily from the parking Kiosk located between the A3 and A11 lots.

You may NOT park in the parking spots along the front marked "Carpool Permit Required". You may use any handicapped parking spots along the front as long as you have proper handicapped plaques or license plates.

RV Parking: Take the 2nd right on Ventura St., past the A4 parking lot and proceed to the back A11 lot. We have a few reserved (guaranteed) spots. RV parking is reserved at entry and is \$30/day (send in with entry). If not reserved in advance, we cannot guarantee there will be an RV spot available. If the RV/Van is small enough to fit in a normal parking space they can use lot A4. Overnight stays ARE allowed, no hook ups.

PARKING. We are not doing pre-pay parking this year (aside from RV parking). We will still primarily be using lot A4. Upon arrival you will need to get a parking permit (\$6) from the parking kiosk (located between lots A4 and A11). We are not guaranteed all the spots in A4, so overflow parking will be lots A11 and A3.

\$6 per day parking available in lot A3. This is the lot just as you enter where the double lane narrows to one. This lot is a little farther away than A4. You need to use a walkway over the wash and into the park / showgrounds. This lot has extra space and can accommodate any size vehicle.

SPECIAL SET UP INSTRUCTIONS: All EZ ups must be kept with at least 3 feet space apart from each other. There is a LOT of shade available at this site, so many may not need EZ ups. Parking is immediately adjacent to the rings, so you can work out of your car. Rings will be enclosed aside from the gates in / out.

There will be ample trashcans available. Please pick up after your dogs and your humans so we can continue to use this lovely new site!

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
